Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), general counsel to Krista L. Freitag (the "Receiver"), the Court-appointed receiver for Defendant Integrated National Resources, Inc., dba Weedgenics, and Relief Defendants West Coast Development LLC, INR Consulting LLC (Wyoming Entity), Oceans 19 Inc., Autobahn Performance LLC, One Click General Media Inc., Opus Collective, INR-CA Investment Holdings, LLC, Total Solution Construction LLC, Bagpipe Holdings LLC, Bagpipe Multimedia LLC, INR Consulting LLC (California Entity), and Hidden Springs Holdings Group LLC, and their subsidiaries and affiliates (collectively the "Receivership Entities"), hereby submits this Third Interim Application for Payment of Fees and Reimbursement of Expenses (the "Application"). This Application covers the period from October 1, 2023 through December 31, 2023 (the "Application Period"), and seeks approval of \$83,751.30 in fees and \$8,788.71 in expenses, and an order authorizing the Receiver to pay, on an interim basis, 80% of the fees incurred (\$67,001.04) and 100% of the expenses incurred (\$8,788.71).

I. **INTRODUCTION.**

This equity receivership involves a large, complex, and wide-ranging group of enterprises and assets associated with the alleged \$61 million fraudulent scheme that is the subject of the Complaint filed by the Securities and Exchange Commission (the "Commission"). The Receiver was appointed on a temporary basis by the Temporary Restraining Order entered on May 19, 2023 ("TRO"), and on a permanent basis on June 2, 2023, pursuant to the Preliminary Injunction Order with Respect to Certain Defendants and Relief Defendants and Orders (1) Freezing Assets; (2) Appointing a Permanent Receiver; (3) Requiring Accountings; and (4) Prohibiting the Destruction of Documents (Dkt. 33) and subsequent Preliminary Injunction Orders entered between June 8, 2023 and June 29, 2023 (Dkt. 48, 49, 93 95) (the "Appointment Order").

The Appointment Order confers broad duties, responsibilities, and powers upon the Receiver, which are designed to allow her to secure, preserve, and protect the assets of the Receivership Entities, conduct a forensic accounting and analysis of the Receivership Entities' financial transactions, investigate and recover sums transferred to third parties, review and analyze investor and creditor claims, and maximize the amount ultimately available for distribution to investors and creditors. The Receiver promptly determined that experienced and qualified counsel was critical to the performance of her duties and obligations under the Appointment Order due to the size and complexity of the receivership estate. Accordingly, the Receiver engaged Allen Matkins to assist with legal issues facing the receivership estate and the firm immediately began work, including assisting with the takeover of the enterprises and securing their assets. The Court approved the Receiver's engagement of Allen Matkins on July 28, 2023. Dkt. 125.

This Application should be read in conjunction with the Receiver's Third Interim Report and Recommendations ("Third Report") filed on December 15, 2023 (Dkt. 201), which describes in detail the Receiver's activities during the Application Period.

This Application seeks approval of \$83,751.30 in fees for a total of 137.60 hours worked, and payment on an interim basis of 80% of that amount, or \$67,001.04. Allen Matkins has agreed to discount its standard hourly rates by 10% for this case. The work performed is described task-by-task in **Exhibit A**¹ and is broken down into the following categories:

Allen Matkins has worked diligently and efficiently to assist the Receiver with legal issues facing the receivership estate. The Firm's work has allowed the Receiver to preserve and protect the substantial value of receivership estate assets. Because the firm has worked diligently and efficiently to assist the Receiver in carrying out her Court-ordered duties, it should be compensated on an interim basis for its work.

II. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED.

A. Categories and Descriptions of Work.

1. <u>General Receivership.</u>

Services in this category relate to assisting the Receiver with matters relating to the general administration of the receivership estate and the underlying litigation. This work included analyzing and advising the Receiver on relevant developments in the case, including discussions and stipulations relating to the unfreezing of certain Defendant and Relief Defendant assets. Allen Matkins also worked on the Receiver's limited opposition to Defendant Hirschmann's motion to stay discovery. Allen Matkins also assisted the Receiver in analyzing and addressing certain tax issues for the Receivership Entities. The reasonable and necessary fees for Allen Matkins' work in this category total \$14,568.75.

2. <u>Asset Investigation & Recovery.</u>

The substantial services in this category relate generally to efforts to investigate, identify, secure, preserve, and recover Receivership Entity assets. As can be expected during the early stage of a receivership involving allegations of a large-scale Ponzi scheme, investigation-related tasks comprised the largest category of Allen Matkins' work during the Application Period. The tasks performed include the following:

- Identifying subpoena targets and issuing subpoenas to financial institutions, vendors, website/domain hosting companies, escrow companies, telecom carriers, recipients of potential receivership assets, and others involved with or otherwise connected to the Receivership Entities or their assets in some manner;
- Issuing demand and asset turnover letters to recipients believed to be in possession of receivership assets in order to enable the Receiver to recover and gain control over the Assets;
- Issuing document preservation letters to recipients believed to be in possession of the Receivership Entities' books and records;
- Gathering, organizing, and reviewing documents and information obtained from third parties including, but not limited to, banking and other financial records, investment records, asset-related purchase and sale documents, legal files, and investor communications;
- Analyzing investor transactions and associated documentation in order to develop a better understanding of the nature and scope of the fraudulent scheme;
- Promptly addressing, communicating with third parties, and assisting the Receiver with recovery of Receivership Entity funds taken by Hirschmann for his personal use; and

 Addressing discovery disputes, including assertions of attorney-client privilege and privacy rights in connection with various third-party subpoenas.

As briefly addressed above, Allen Matkins devoted considerable time to recovering receivership assets under the control of Hirschman, including two real properties located in Boise, Idaho area and two BMW vehicles. As noted above, Allen Matkins also spent considerable time working to locate and recover electronic data of the receivership entities and to identify those associated with the destruction and/or loss of receivership entity records and data.

The firm also assisted the Receiver in providing the required notice of lease termination to the tenant occupying the receivership property located in Las Vegas (known as the "Gracemoor Property") such that Receiver can recover possession (which she now has) and prepare the property to be marketed and sold. Allen Matkins also assisted the Receiver in addressing issues with the Gracemoor Property, including (a) a claim by the homeowners' association ("HOA") that certain construction at the property was not approved by the HOA, and (b) a lien recorded against the property by a vendor of security screens that was not fully paid for a pre-receivership purchase order.

Finally, the firm reviewed documents produced by certain third parties, interviewed various witnesses, and analyzed potential claims the receivership estate may have to recover funds from third parties for the benefit of investor victims of the Ponzi scheme. Through these efforts, along with her forensic accounting, the Receiver has identified various third parties against whom she plans to pursue claims (including fraudulent transfer claims and potentially others) to recover funds for distribution to investors with losses from the Ponzi scheme. The Court recently authorized the Receiver to pursue fraudulent transfer claims and to settle such claims within certain pre-approved parameters. Dkt. 218.

The reasonable and necessary fees for Allen Matkins' work in this category total \$52,680.15.

3. Reporting.

Allen Matkins' services in this category were focused on preparing the Receiver's Third Report and Recommendations, which was filed on December 15, 2023. Dkt. 201. The reasonable and necessary fees for Allen Matkins' work in this category total \$2,134.35.

4. Operations & Asset Sales.

Allen Matkins' services in this category were focused on advising the Receiver regarding the limited operations of Rari Nutrition, an affiliated Receivership Entity that sold nutritional supplements through the Amazon website. The reasonable and necessary fees for Allen Matkins' work in this category total \$826.20.

5. <u>Claims & Distributions.</u>

Services rendered in this category generally relate to the claims and interests of investors and creditors of the Receivership Entities. Allen Matkins assisted with issues related to disseminating information about the receivership to investor and creditors, including notification letters, and information provided on the receivership website (www.inrreceivership.com). The firm also assisted in responding to direct inquiries from investors and creditors. The reasonable and necessary fees for Allen Matkins' work in this category total \$2,203.20.

6. Third Party Recoveries.

Allen Matkins' work in this category focused on assisting with and preparing the Receiver's motion for authority to pursue fraudulent transfer (or "clawback") claims against those who received profits, gratuitous transfers, or other amounts from the Ponzi scheme. Dkt. 197. The motion included a proposed settlement process and a request for authority to settle claims within certain pre-approved

parameters. The motion was recently granted. Dkt. 218. The reasonable and necessary fees for Allen Matkins' work in this category total \$11,132.10.

7. **Employment/Fees.**

Neither the Receiver nor Allen Matkins charge for preparing their own detailed fee applications. Allen Matkins assisted in preparing the Receiver's first interim fee applications and in meeting and conferring with counsel for the Securities and Exchange Commission before the first interim fee applications were filed. The reasonable and necessary fees for Allen Matkins' work in this category total \$206.55.

В. **Summary of Expenses Requested for Reimbursement.**

Allen Matkins requests that the Court approve reimbursement of \$8,788.71 in out-of-pocket costs. The itemization of such expenses is summarized below by billing category. The majority of the expenses incurred relate to the issuance and service of subpoenas. As explained above, Allen Matkins issued subpoenas and gathered documents from many third parties and financial institutions. Each of these subpoenas required proper service.

The total for costs incurred by Allen Matkins during the Application Period is \$8,788.71 and is broken down by category as follows:

III. THE FEES AND COSTS ARE REASONABLE AND SHOULD BE ALLOWED.

"As a general rule, the expenses and fees of a receivership are a charge upon the property administered." *Gaskill v. Gordon*, 27 F.3d 248, 251 (7th Cir. 1994). These expenses include the fees and expenses of this Receiver and her professionals, including Allen Matkins. Decisions regarding the timing and amount of an award of fees and costs to the Receiver and her professionals are committed to the sound discretion of the Court. *See SEC v. Elliot*, 953 F.2d 1560, 1577 (11th Cir. 1992) (rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)).

In allowing fees, a court should consider "the time, labor and skill required, but not necessarily that actually expended, in the proper performance of the duties imposed by the court upon the receiver . . . , the fair value of such time, labor and skill measured by conservative business standards, the degree of activity, integrity and dispatch with which the work is conducted and the result obtained." *United States v. Code Prods. Corp.*, 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation marks omitted). In practical terms, receiver and professional compensation thus ultimately rests upon the result of an equitable, multi-factor balancing test involving the "economy of administration, the burden that the estate may be able to bear, the amount of time required, although not necessarily expended, and the overall value of the services to the estate." *In re Imperial 400 Nat'l, Inc.*, 432 F.2d 232, 237 (3d Cir. 1970). Regardless of how this balancing test is formulated, no single factor is determinative and "a reasonable fee is based [upon] all circumstances surrounding the receivership." *SEC v. W.L. Moody & Co., Bankers (Unincorporated)*, 374 F. Supp. 465, 480 (S.D. Tex. 1974).

As a preliminary matter, the Appointment Order confer on the Receiver substantial duties and powers, including to conduct such investigation and discovery as may be necessary to locate and account for all Receivership Assets, to take such action as is necessary and appropriate to assume control over and preserve

Receivership Assets, and to employ attorneys and others to investigate and, where appropriate, institute, pursue, and prosecute all claims and causes of action of whatever kind and nature. *See* Appointment Order, Section X.

As previously noted, the Receiver promptly determined that utilizing a few third-party vendors and her experienced staff at E3 as well as experienced, qualified counsel was critical due to the lack of records, size and complexity of the receivership estate. The Receiver sought approval and the Court approved her engagement of Allen Matkins and the ability to file interim reports and fee applications on a quarterly basis via the Order Regarding Aid of Receivership. Dkt. 60, 125.

Allen Matkins has submitted a detailed fee application which describes the nature of the services rendered. *See* Exhibit A. Allen Matkins has endeavored to staff matters as efficiently as possible while remaining cognizant of the complexity of issues presented. As noted above, the request for fees is based on Allen Matkins' customary billing rates charged for comparable services provided in other matters, less a 10% discount. Moreover, Allen Matkins wrote off and did not charge for 2.30 hours of work (\$1,583.55 in fees).

The work performed by Allen Matkins was essential to carrying out the Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked diligently since the Receiver's appointment to preserve and protect the assets of the receivership estate, maximize the funds available for ultimate distribution to investors, and carry out the Receiver's other duties pursuant to the Appointment Order. Moreover, Allen Matkins seeks payment of only 80% of fees incurred on an interim basis in recognition of the fact that its work in assisting the Receiver is ongoing. Payment of the proposed 20% holdback will be sought at the conclusion of the receivership. Allen Matkins' fees are fair and reasonable and should be approved and paid on an interim basis.

IV. **CONCLUSION.** 1 Allen Matkins therefore respectfully request that this Court enter an Order: 2 3 1. Approving Allen Matkins' fees of \$83,751.30; Authorizing and directing the Receiver to pay 80% of approved fees, or 2. 4 \$67,001.04, from the assets of the Receivership Entities; 5 Approving Allen Matkins' costs in the amount of \$8,788.71, and 6 3. authorizing and directing the Receiver to reimburse such costs in full; and 7 4.
