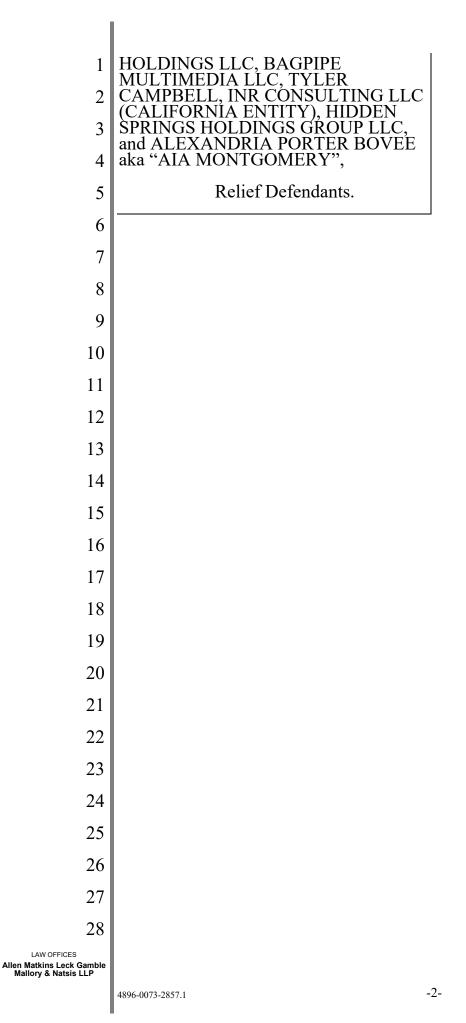

Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins"), 1 general counsel to Krista L. Freitag (the "Receiver"), the Court-appointed receiver 2 for Defendant Integrated National Resources, Inc., dba Weedgenics ("INR"), and 3 Relief Defendants West Coast Development LLC, INR Consulting LLC (Wyoming 4 Entity), Oceans 19 Inc., Autobahn Performance LLC, One Click General Media 5 Inc., Opus Collective, INR-CA Investment Holdings, LLC, Total Solution 6 Construction LLC, Bagpipe Holdings LLC, Bagpipe Multimedia LLC, INR 7 8 Consulting LLC (California Entity), and Hidden Springs Holdings Group LLC, and their subsidiaries and affiliates (collectively the "Receivership Entities"), hereby 9 submits this Fourth Interim Application for Payment of Fees and Reimbursement of 10 Expenses (the "Application"). This Application covers the period from January 1, 11 2024 through March 31, 2024 (the "Application Period"), and seeks approval of 12 \$156,533.85 in fees and \$4,326.96 in expenses, and an order authorizing the 13 Receiver to pay, on an interim basis, 80% of the fees incurred (\$125,227.08) and 14 100% of the expenses incurred (\$4,326.96). 15

### **INTRODUCTION.**

I.

17 This equity receivership involves a large, complex, and wide-ranging group of enterprises and assets associated with the alleged \$61 million fraudulent scheme 18 19 that is the subject of the Complaint filed by the Securities and Exchange 20 Commission (the "Commission"). The Receiver was appointed on a temporary basis by the Temporary Restraining Order entered on May 19, 2023 ("TRO"), and 21 22 on a permanent basis on June 2, 2023, pursuant to the Preliminary Injunction Order 23 with Respect to Certain Defendants and Relief Defendants and Orders (1) Freezing Assets; (2) Appointing a Permanent Receiver; (3) Requiring Accountings; and (4) 24 25 Prohibiting the Destruction of Documents (Dkt. 33) and subsequent Preliminary Injunction Orders entered between June 8, 2023 and June 29, 2023 (Dkt. 48, 49, 93 26 27 95) (the "Appointment Order").

The Appointment Order confers broad duties, responsibilities, and powers 1 2 upon the Receiver, which are designed to allow her to secure, preserve, and protect the assets of the Receivership Entities, conduct a forensic accounting and analysis of 3 the Receivership Entities' financial transactions, investigate and recover sums 4 transferred to third parties, review and analyze investor and creditor claims, and 5 maximize the amount ultimately available for distribution to investors and creditors. 6 7 The Receiver promptly determined that experienced and qualified counsel was 8 critical to the performance of her duties and obligations under the Appointment 9 Order due to the size and complexity of the receivership estate. Accordingly, the Receiver engaged Allen Matkins to assist with legal issues facing the receivership 10 estate and the firm immediately began work, including assisting with the takeover of 11 the enterprises and securing their assets. The Court approved the Receiver's 12 engagement of Allen Matkins on July 28, 2023. Dkt. 125. 13

This Application should be read in conjunction with the Receiver's Fifth
Interim Report and Recommendations ("Fifth Report") filed on May 17, 2024
(Dkt. 233), which describes in detail the Receiver's activities during the Application
Period.

This Application seeks approval of \$156,533.85 in fees for a total of 289.30
hours worked, and payment on an interim basis of 80% of that amount, or
\$125,227.08. Allen Matkins has agreed to discount its standard hourly rates by 10%
for this case. The work performed is described task-by-task in <u>Exhibit A<sup>1</sup></u> and is
broken down into the following categories:

- While Allen Matkins has made efforts to ensure that its billing entries are consistent across categories, certain activities lend themselves to more than one category, or may be difficult to categorize. In any event, <u>Exhibit A</u> reflects the actual time spent by Allen Matkins personnel, and contains accurate descriptions of the services rendered.

9 Allen Matkins has worked diligently and efficiently to assist the Receiver
10 with legal issues facing the receivership estate. The Firm's work has allowed the
11 Receiver to preserve and protect the substantial value of receivership estate assets.
12 Because the firm has worked diligently and efficiently to assist the Receiver in
13 carrying out her Court-ordered duties, it should be compensated on an interim basis
14 for its work.

### II. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED.

16

A.

### 1. <u>General Receivership.</u>

**Categories and Descriptions of Work.** 

18 Services in this category relate to assisting the Receiver with matters relating 19 to the general administration of the receivership estate and the underlying litigation. 20 This work included analyzing and advising the Receiver on relevant developments 21 in the case, including discussions and stipulations relating to the extension of case 22 dates and deadlines. The firm also handle various discovery-related matters and 23 responded to Defendant Hirschmann's request that certain personal belongings left 24 at one of the receivership properties be returned to him. Allen Matkins also assisted 25 the Receiver in analyzing and addressing certain tax issues for the Receivership 26 Entities. The reasonable and necessary fees for Allen Matkins' work in this 27 category total \$4,158.45.

### Asset Investigation & Recovery.

The substantial services in this category relate generally to efforts to
investigate, identify, secure, preserve, and recover Receivership Entity assets. As
can be expected during the early stage of a receivership involving allegations of a
large-scale Ponzi scheme, investigation-related tasks comprised the largest category
of Allen Matkins' work during the Application Period. The tasks performed include
the following:

8	•	Identifying subpoena targets and issuing subpoenas to financial
9		institutions, vendors, website/domain hosting companies, escrow
10		companies, telecom carriers, recipients of potential receivership assets,
11		and others involved with or otherwise connected to the Receivership
12		Entities or their assets in some manner;
13	•	Issuing demand and asset turnover letters to recipients believed to be in
14		possession of receivership assets in order to enable the Receiver to
15		recover and gain control over the Assets;
16	•	Issuing document preservation letters to recipients believed to be in
17		possession of the Receivership Entities' books and records;
18	•	Gathering, organizing, and reviewing documents and information
19		obtained from third parties including, but not limited to, banking and
20		other financial records, investment records, asset-related purchase and
21		sale documents, legal files, and investor communications;
22	•	Analyzing investor transactions and associated documentation in order
23		to develop a better understanding of the nature and scope of the
24		fraudulent scheme; and
25	•	Addressing discovery disputes, including assertions of attorney-client
26		privilege and privacy rights in connection with various third-party
27		subpoenas.
28		

1 Allen Matkins devoted considerable time to gathering and analyzing 2 documents from third parties and interviewing witnesses for the purpose of 3 evaluating potential claims to recover funds on behalf of the receivership estate. The investigation and analysis has focused on, among other things, tours given by 4 Defendant Hirschmann to prospective investors in the Ponzi scheme at a cannabis 5 facility located in Las Vegas (not owned or operated by the Defendants or Relief 6 7 Defendants) and the circumstances in which those tours were allowed to take place. These tours were critical to the growth of the Ponzi scheme (investors saw the 8 9 facility first hand and were lead to believe it was owned and operated by INR) and have taken time to investigative due to the systematic destruction of emails and text 10 messages by persons associated with the scheme and the fact that the owner of the 11 12 cannabis facility has, thus far, denied having any contact with Hirschmann or any other persons associated with the scheme. 13

The investigation has also focused on the law firms that represented INR and
assisted the Defendants and Relief Defendants who were operating the Ponzi
scheme. Allen Matkins' investigative work also included planning and preparing
for depositions that are expected to take place in July and August 2024. Attorney
Ted Fates also attended the depositions of Relief Defendants Tyler Campbell and
Michael Delgado, which depositions were taken by counsel for the SEC.

Through these efforts, along with her forensic accounting, the Receiver has identified various third parties against whom she plans to pursue claims (including fraudulent transfer claims and potentially others) to recover funds for distribution to investors with losses from the Ponzi scheme. The Court has authorized the Receiver to pursue fraudulent transfer claims and to settle such claims within certain preapproved parameters. Dkt. 218.

Allen Matkins also assisted the Receiver in addressing issues with the
Gracemoor Property, including (a) a claim by the homeowners' association
("HOA") that certain construction at the property was not approved by the HOA,

and (b) a lien recorded against the property by a vendor of security screens that was
 not fully paid for a pre-receivership purchase order.

3 The reasonable and necessary fees for Allen Matkins' work in this category
4 total \$144,526.50.

5

### 3. <u>Reporting.</u>

Allen Matkins' services in this category were focused on preparing the
Receiver's Fourth Report and Recommendations, which was filed on February 13,
2024. Dkt. 209. The reasonable and necessary fees for Allen Matkins' work in this
category total \$1,996.65.

### 4. **Operations & Asset Sales.**

Allen Matkins' services in this category were focused on advising the
Receiver regarding issues relating to the prospective sale of real property located in
Boise, Idaho (known as the Hacienda Property). The reasonable and necessary fees
for Allen Matkins' work in this category total \$206.55.

### 5. <u>Claims & Distributions.</u>

16 Services rendered in this category generally relate to the claims and interests of investors and creditors of the Receivership Entities. Allen Matkins assisted with 17 18 issues related to disseminating information about the receivership to investor and 19 creditors, including notification letters, and information provided on the receivership website (www.inrreceivership.com). The firm also assisted in responding to direct 20 inquiries from investors and creditors. Finally, the firm assisted the Receiver in 21 22 getting an HOA lien recorded in violation of the Preliminary Injunction Order 23 removed from title to the receivership real property located in Las Vegas (known as the Gracemoor Property). The reasonable and necessary fees for Allen Matkins' 24 25 work in this category total \$4,681.80.

26

### 6. <u>Employment/Fees.</u>

27 Neither the Receiver nor Allen Matkins charge for preparing their own
28 detailed fee applications. Allen Matkins assisted in preparing the Receiver's second

interim fee applications and in meeting and conferring with counsel for the
 Securities and Exchange Commission before the second interim fee applications
 were filed. The reasonable and necessary fees for Allen Matkins' work in this
 category total \$963.90.

### A. Summary of Expenses Requested for Reimbursement.

Allen Matkins requests that the Court approve reimbursement of \$4,326.96 in
out-of-pocket costs. The itemization of such expenses is summarized below by
billing category. The majority of the expenses incurred relate to the issuance and
service of subpoenas. As explained above, Allen Matkins issued subpoenas and
gathered documents from many third parties and financial institutions. Each of
these subpoenas required proper service.

12 The total for costs incurred by Allen Matkins during the Application Period is13 \$4,326.96 and is broken down by category as follows:

## III. <u>THE FEES AND COSTS ARE REASONABLE AND SHOULD BE</u> <u>ALLOWED.</u>

"As a general rule, the expenses and fees of a receivership are a charge upon
the property administered." *Gaskill v. Gordon*, 27 F.3d 248, 251 (7th Cir. 1994).
These expenses include the fees and expenses of this Receiver and her professionals,
including Allen Matkins. Decisions regarding the timing and amount of an award of
fees and costs to the Receiver and her professionals are committed to the sound

discretion of the Court. See SEC v. Elliot, 953 F.2d 1560, 1577 (11th Cir. 1992)
 (rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)).

In allowing fees, a court should consider "the time, labor and skill required, 3 but not necessarily that actually expended, in the proper performance of the duties 4 imposed by the court upon the receiver ..., the fair value of such time, labor and 5 skill measured by conservative business standards, the degree of activity, integrity 6 7 and dispatch with which the work is conducted and the result obtained." United 8 States v. Code Prods. Corp., 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation marks omitted). In practical terms, receiver and professional compensation thus 9 ultimately rests upon the result of an equitable, multi-factor balancing test involving 10 the "economy of administration, the burden that the estate may be able to bear, the 11 12 amount of time required, although not necessarily expended, and the overall value of the services to the estate." In re Imperial 400 Nat'l, Inc., 432 F.2d 232, 237 (3d Cir. 13 14 1970). Regardless of how this balancing test is formulated, no single factor is 15 determinative and "a reasonable fee is based [upon] all circumstances surrounding the receivership." SEC v. W.L. Moody & Co., Bankers (Unincorporated), 374 F. 16 17 Supp. 465, 480 (S.D. Tex. 1974).

As a preliminary matter, the Appointment Order confer on the Receiver
substantial duties and powers, including to conduct such investigation and discovery
as may be necessary to locate and account for all Receivership Assets, to take such
action as is necessary and appropriate to assume control over and preserve
Receivership Assets, and to employ attorneys and others to investigate and, where
appropriate, institute, pursue, and prosecute all claims and causes of action of
whatever kind and nature. *See* Appointment Order, Section X.

As previously noted, the Receiver promptly determined that utilizing a few
third-party vendors and her experienced staff at E3 as well as experienced, qualified
counsel was critical due to the lack of records, size and complexity of the
receivership estate. The Receiver sought approval and the Court approved her

engagement of Allen Matkins and the ability to file interim reports and fee
 applications on a quarterly basis via the Order Regarding Aid of Receivership.
 Dkt. 60, 125.

Allen Matkins has submitted a detailed fee application which describes the
nature of the services rendered. *See* Exhibit A. Allen Matkins has endeavored to
staff matters as efficiently as possible while remaining cognizant of the complexity
of issues presented. As noted above, the request for fees is based on Allen Matkins'
customary billing rates charged for comparable services provided in other matters,
less a 10% discount. Moreover, Allen Matkins wrote off and did not charge for 2.20
hours of work (\$1,514.70 in fees).

11 The work performed by Allen Matkins was essential to carrying out the Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked 12 diligently since the Receiver's appointment to preserve and protect the assets of the 13 receivership estate, maximize the funds available for ultimate distribution to 14 investors, and carry out the Receiver's other duties pursuant to the Appointment 15 Order. Moreover, Allen Matkins seeks payment of only 80% of fees incurred on an 16 interim basis in recognition of the fact that its work in assisting the Receiver is 17 ongoing. Payment of the proposed 20% holdback will be sought at the conclusion 18 19 of the receivership. Allen Matkins' fees are fair and reasonable and should be 20 approved and paid on an interim basis.

### IV. <u>CONCLUSION.</u>

Allen Matkins therefore respectfully request that this Court enter an Order:

- 23
- 1. Approving Allen Matkins' fees of \$156,533.85;

24 2. Authorizing and directing the Receiver to pay 80% of approved fees, or
25 \$125,227.08, from the assets of the Receivership Entities;
