1 Krista Freitag ("Receiver"), the Court-appointed permanent receiver for Defendant, Integrated National Resources, Inc., dba Weedgenics, and Relief 2 Defendants, West Coast Development LLC, INR Consulting LLC (Wyoming Entity), Oceans 19 Inc., Autobahn Performance LLC, One Click General Media 4 Inc., Opus Collective, INR-CA Investment Holdings, LLC, Total Solution 5 Construction LLC, Bagpipe Holdings LLC, Bagpipe Multimedia LLC, INR 6 Consulting LLC (California Entity), and Hidden Springs Holdings Group LLC, and 7 8 their subsidiaries and affiliates (collectively the "Receivership Entities"), hereby submits this Sixth Interim Application for Payment of Fees and Reimbursement of Expenses (the "Application"). # INTRODUCTION.

This equity receivership involves a large, complex, and wide-ranging group of enterprises and assets associated with the alleged \$61 million fraudulent scheme that is the subject of the Complaint filed by the Securities and Exchange Commission (the "Commission"). The Receiver was appointed as temporary receiver pursuant to a Temporary Restraining Order (the "TRO") dated May 19, 2023 (Dkt. 17) and as permanent receiver on June 2, 2023, pursuant to the Preliminary Injunction Order with Respect to Certain Defendants and Relief Defendants and Orders (1) Freezing Assets; (2) Appointing a Permanent Receiver; (3) Requiring Accountings; and (4) Prohibiting the Destruction of Documents (Dkt. 33) and subsequent Preliminary Injunction Orders entered between June 8, 2023 and June 29, 2023 (Dkt. 48, 49, 93 95) (collectively, the "Appointment Order").

The Appointment Order confers broad duties, responsibilities, and powers upon the Receiver, which are designed to allow her to secure, preserve, and protect the assets of the Receivership Entities, conduct a forensic accounting and analysis of the Receivership Entities' financial transactions, investigate and recover sums transferred to third parties, review and analyze investor and creditor claims, and maximize the amount ultimately available for distribution to investors and creditors. The Appointment Order also authorizes the Receiver to "employ attorneys, accountants, appraisers and others" to assist her in the performance of her duties. (e.g., Dkt. 33, Section 12(F)). The Receiver promptly determined that utilizing a few third-party vendors and her experienced staff at E3 Realty Advisors, Inc. dba E3 Advisors ("E3"), as well as experienced, qualified counsel was critical due to the lack of records, size and complexity of the receivership estate. Accordingly, the Receiver has used her team at E3 and engaged a few third-party vendors (e.g., forensic accounting and computer), to assist in carrying out receivership duties and engaged Allen Matkins Leck Gamble Mallory & Natsis LLP ("Allen Matkins") as her general counsel for the receivership. The Court approved the Receiver's engagement of Allen Matkins on July 28, 2023. Dkt. 125.

This Application should be read in conjunction with the Receiver's Seventh Interim Report and Recommendations ("Seventh Report") filed on November 19, 2024 (Dkt. 293), which describes in detail the Receiver's activities during the Application Period.

This Application seeks approval of \$225,792.00 in fees for a total of 749.8 hours worked, and payment on an interim basis of 80% of that amount, or \$180,633.60. The Receiver has agreed to discount her standard hourly rates by 10% for this case. The work performed is described task-by-task in **Exhibit A** and is broken down into the following categories:

A complex equity receivership involves substantial work by the receiver and her professionals to (a) identify and secure assets, (b) preserve their value and upon receipt of Court approval, monetize same, (c) investigate and pursue recovery of funds disbursed from the Receivership Entities' accounts, (d) investigate any operations and/or issues associated therewith, if any, (e) gather and review key documents and investigate potential third-party claims, (f) complete the Court-ordered forensic accounting and (g) advise the Court on the status of the Receiver's activities, among other areas of work.

Despite the challenges of getting little to no cooperation from defendants and relief defendants, the Receiver and her team have been able to make substantial progress in identifying, recovering and otherwise pursuing the Receivership Entities' assets and discharging her duties. Among other accomplishments, the Receiver and her team managed to make substantial progress on the ever-important forensic accounting<sup>1</sup> and recover the following assets through September 30, 2024:

The Receiver filed her forensic accounting on October 31, 2024 (Dkt. No. 289).

• Over \$8 million in cash,

- Fourteen (14) mostly exotic and luxury vehicles,
- Six (6) real properties, and
- Numerous pieces of jewelry and artwork.

The largest category of work – the Asset Disposition Category - represents nearly 39% of the fees incurred during the Application Period. Upon receipt of the Court's April 9, 2024 order approving the sale of receivership assets, the Receiver and her staff geared up to execute upon such Order. During the Application Period, six (6) vehicles sold and the Receiver entered sale contracts on and filed for Court approval of four (4) of the real property assets, all of which were subsequently approved by the Court and have since closed. Nearly \$1.7 million of net sale proceeds for the six vehicles and two of the four real properties were collected during the Application Period.

The second largest category of work - the Forensic Accounting category – represents nearly 36% of the fees incurred during the Application Period. An accounting is a critical tool in all fraud cases, but particularly in this case as no accounting records for the Receivership Entities were ever located or produced and the Receiver's accounting (working from scratch) has helped identify the assets recovered to date and other potentially recoverable assets. The accounting established, among other things, where the funds obtained by the Receivership Entities came from and where they went after they were received by the Receivership Entities, as well as provides the foundation for the Receiver's review and analysis of investor and other creditor claims. Of note, the breadth of this accounting exceeded 50,000 transactions and \$350,000,000 of transactional activity. As noted above, the Receiver filed her forensic accounting report on October 31, 2024.

As of September 30, 2024, very important work remained to be done, including continued pursuit of asset recovery, 2 asset sales, 3 completion of the forensic accounting, investigation of causes of action and recovery therefrom, and the investor claims and distribution process.<sup>5</sup> The Receiver has worked diligently to describe in detail the work performed by her and her staff in the billing attached hereto as **Exhibit A**, and has worked diligently and efficiently on the urgent issues facing the receivership estate and in carrying out her Court-ordered duties and should be compensated on an interim basis for her work. II. SUMMARY OF TASKS PERFORMED AND COSTS INCURRED. Α. **Categories and Descriptions of Work** 1. General Receivership. Services in this category relate to matters concerning the general administration of the receivership estate and the underlying litigation. The Receiver and her team's work in this category during the Application Period relate to efforts associated with assessing telephone records. Most fees incurred in this category are non-recurring. The reasonable and necessary fees for Receiver's work in this category total \$382.50. The Receiver and her team have identified transfers of receivership estate cash and other assets, recovery efforts for which remain ongoing. Upon receipt of the Court's April 9, 2024 order authorizing the sale of receivership assets, and as previously discussed, time and expense associated with asset sales increased in the second and third quarters of 2024. Substantial progress was made during the Application Period; the time associated with this category remained steady until the Receiver's forensic accounting report was filed on October 31, 2024 (Dkt. No. 289), at which time the Receiver and her team's efforts transitioned to the claims and distribution process. The Receiver's motion for approval of proposed procedures for the administration of claims was filed on February 4, 2025 (Dkt. No. 307) and

### 2. **Asset Investigation & Recovery.**

The services in this category relate generally to efforts to investigate, identify, secure/preserve, and recover receivership estate assets. The vast majority of the work included in this category during the Application Period revolved around the Receiver and her team's efforts to investigate potential real properties associated with Defendant Williams and preparing for and attending several depositions of third parties.

Most fees incurred in this category are non-recurring. The reasonable and necessary fees for the Receiver's work in this category total \$13,520.25.

#### 3. **Asset Disposition.**

The Receiver's services in this category ramped up upon receipt of the Court's April 9, 2024 order re: the Receiver's Notice of Motion and Receiver's Motion for Authority to (A) Engage Licensed Auctioneers and Dealers to Assist in Selling Personal Property, (B) Sell Automobiles, Jewelry, and Other Personal Property of the Receivership Entities, and (C) Engage Brokers to List Real Properties for Sale filed on September 29, 2023 (Dkt. 162).

During the Application Period, these efforts primarily included interviewing potential vendors for personal property sales, monitoring the marketing and sale efforts of all retained brokers and the vehicle auctioneer, negotiating and executing documentation and delivery for six (6) vehicle sales, negotiating and executing documentation to get four (4) real properties under contract; preparing all necessary documentation to seek Court approval thereof, managing/reviewing/executing all tasks necessary to close on the sale of two real properties, and continuing to efforts to sell the unsold vehicles and real property.

As expected, the time associated with this category remained significant during this Application Period and resulted in the recovery of net sale proceeds totaling nearly \$1.7 million. Time in this category will remain notable, but is

expected to decrease through the next few quarters as the assets sell. The reasonable and necessary fees for Receiver's work in this category total \$98,484.75.

## Reporting.

The Receiver's services in this category were focused on preparing the Receiver's Sixth Interim Report and Recommendations, which was filed on August 2, 2024 (Dkt. 267). The reasonable and necessary fees for Receiver's work in this category total \$6,453.00.

#### 5. Accounting, Estate Administration

The majority of the work in this category during the Application Period was associated with attempting to address general, ongoing property related management oversight, including time associated with cancelling utilities, insurance, HOA payments, and related matters once the assets are sold, as well as general receivership estate related tasks.

The general, ongoing administration of the estate tasks include but are not limited to processing receivership estate mail and payables and generally accounting for the receivership estate, including processing net sales proceeds. Such tasks are recurring during the pendency of the receivership; however, will decrease as the physical assets are monetized through the sale thereof. The reasonable and necessary fees for Receiver's work in this category during the Application Period total \$19,968.75.

#### 6. **Investors, Claims & Distributions.**

Services rendered in this category generally relate to the ever-important communication with investors and eventually the claims and distribution processes established for the benefit of the investors and creditors of the Receivership Entities.

During the Application Period, the Receiver and her team's time primarily represented responses to direct inquiries from investors regarding the receivership, the impact of the receivership, and the prospective investor claims/distribution process as well as the commencement of review of investor records obtained in

conjunction with completing the forensic accounting analysis and in preparation for the claims process. The reasonable and necessary fees for Receiver's work in this category total \$7,773.75.

## 7. **Operations**

As discussed in her prior reports, the Receiver discovered an operating business owned by Raw Sports, LLC (a Hirschmann controlled entity), which had recently purchased Rari Nutrition ("Rari"). Rari was a nutritional supplements company largely sold through the Amazon.com website, but also through its own website at rarinutrition.com.<sup>6</sup> After gaining an understanding of the status of the operations and profitability thereof, the intellectual property status, the product and inventory status and feasibility of an eventual sale of the business a wind down of operations occurred during the fourth quarter of 2023. Despite the wind down, the former owner of Rari expressed an interest in purchasing what remained of the assets and so minimal time was spent during the Application Period assessing whether a transaction could be economically completed.

The reasonable and necessary fees for the Receiver's work in this category total \$76.50 during the Application Period.

# 8. <u>Forensic Accounting</u>

During the Application Period, this category reflects the Receiver's final stages of the global forensic accounting process, which includes processing the final bank-related production documentation, working to complete investor transactional activity reconciliations, reviewing/finalizing the categorization of all transactions, creating exhibits for the forensic accounting report, and working to draft and towards completion of the forensic accounting report.

Due to the complexity and scope of the scheme, the number of affiliated entities and bank accounts used, the high volume of transfers to, from, and between

filed her forensic accounting report on October 31, 2024.

Receivership Entities and the defendants and relief defendants, and the lack of any company accounting or investor data, the forensic accounting project takes time to complete. That said, because of the critical nature of bank record review, the Receiver used a project-specific and cost-effective AI software to upload the tens of thousands of banking transactions into a database. This software has saved considerable time and expense on the forensic accounting data, which exceeded 50,000 transactions and over \$350,000,000 of transactional volume. The Receiver

The accounting is a critical tool in all Ponzi scheme cases, but particularly in this case as it has provided for the identification and recovery of material assets and prospectively recoverable assets, and established, among other things, where the funds obtained by the Receivership Entities came from and where they went after they were received by the Receivership Entities. The accounting will also provide the foundation for the Receiver's review and analysis of investor and any creditor claims. The reasonable and necessary fees for Receiver's work in this category total \$74,551.50.

#### 9. **Taxes**

During the Application Period, this category reflects the Receiver's early-stage work on the receivership entity tax reporting research and review. The reasonable and necessary fees for Receiver's work in this category total \$4,581.00.

### В. **Summary of Expenses Requested for Reimbursement.**

The Receiver requests that the Court approve reimbursement of \$7,098.65 in out-of-pocket costs. The itemization of such expenses is attached hereto as **Exhibit B** and is summarized below by category. The majority of the expenses incurred relate to third-party forensic accounting software expenses and vehicle registration fees. Other expenses incurred include other miscellaneous receivership administrative and asset related costs.

## IV. THE FEES AND COSTS ARE REASONABLE AND SHOULD BE ALLOWED.

"As a general rule, the expenses and fees of a receivership are a charge upon the property administered." Gaskill v. Gordon, 27 F.3d 248, 251 (7th Cir. 1994). These expenses include the fees and expenses of this Receiver and her professionals, including Allen Matkins. Decisions regarding the timing and amount of an award of fees and costs to the Receiver and her professionals are committed to the sound discretion of the Court. See SEC v. Elliot, 953 F.2d 1560, 1577 (11th Cir. 1992) (rev'd in part on other grounds, 998 F.2d 922 (11th Cir. 1993)).

In allowing fees, a court should consider "the time, labor and skill required, but not necessarily that actually expended, in the proper performance of the duties imposed by the court upon the receiver . . . , the fair value of such time, labor and skill measured by conservative business standards, the degree of activity, integrity and dispatch with which the work is conducted and the result obtained." *United* States v. Code Prods. Corp., 362 F. 2d 669, 673 (3d Cir. 1966) (internal quotation

marks omitted). In practical terms, receiver and professional compensation thus ultimately rests upon the result of an equitable, multi-factor balancing test involving the "economy of administration, the burden that the estate may be able to bear, the amount of time required, although not necessarily expended, and the overall value of the services to the estate." *In re Imperial 400 Nat'l, Inc.*, 432 F.2d 232, 237 (3d Cir. 1970). Regardless of how this balancing test is formulated, no single factor is determinative and "a reasonable fee is based [upon] all circumstances surrounding the receivership." *SEC v. W.L. Moody & Co., Bankers (Unincorporated)*, 374 F. Supp. 465, 480 (S.D. Tex. 1974).

As a preliminary matter, the Appointment Orders confer on the Receiver substantial duties and powers, including to conduct such investigation and discovery as may be necessary to locate and account for all receivership assets, to take such action as is necessary and appropriate to assume control over and preserve receivership assets, and to employ attorneys and others to investigate and, where appropriate, institute, pursue, and prosecute all claims and causes of action of whatever kind and nature. *See* Appointment Order, Section X.

As previously noted, the Receiver promptly determined that utilizing a few third-party vendors and her experienced staff at E3 as well as experienced, qualified counsel was critical due to the lack of records, size and complexity of the receivership estate. The Receiver sought approval and the Court approved her engagement of Allen Matkins and the ability to file interim reports and fee applications on a quarterly basis via the Order Regarding Aid of Receivership. Dkt. 60.

The Receiver has submitted a detailed fee application which describes the nature of the services rendered, and the identity and billing rate of each individual performing each task. See **Exhibit A**. The Receiver endeavors to staff matters as efficiently as possible, while remaining cognizant of the complexity of issues

presented. The request for fees is based on the Receiver's customary billing rates charged for comparable services provided in other matters, less a 10% discount.

The work performed by the Receiver and her team was essential to carrying out the Receiver's Court-ordered duties. The Receiver and Allen Matkins have worked diligently since the Receiver's appointment to preserve and protect the assets of the receivership estate, maximize the funds available for ultimate distribution to investors, and carry out the Receiver's other duties pursuant to the Appointment Order. Moreover, the Receiver seeks payment of only 80% of fees incurred on an interim basis in recognition of the fact that her work is ongoing. Payment of the proposed 20% holdback will be sought at the conclusion of the receivership. The Receiver's fees are fair and reasonable and should be approved and paid on an interim basis.

## V. CONCLUSION.

The Receiver therefore respectfully request that this Court enter an Order:

- 1. Approving the Receiver's fees of \$225,792.00;
- 2. Authorizing and directing the Receiver to pay 80% of approved fees, or \$180,633.60, from the assets of the Receivership Entities;
- 3. Approving the Receiver's costs in the amount of \$7,098.65, and authorizing and directing the Receiver to reimburse such costs in full; and
  - 4. For such other and further relief as the Court deems appropriate.
