Proceedings: HEARING RE RECEIVER'S TENTH INTERIM FEE REQUESTS [410 & 411]; RECEIVER'S MOTION FOR APPROVAL OF SETTLEMENT [419]; RECEIVER'S ELEVENTH INTERIM FEE REQUESTS [420 & 421]

Counsel state their appearances. Also present is Relief Defendant Michael Delgado. The Court confers with counsel and hears oral argument. For the reasons stated on the record, the Court hereby **ORDERS** as follows:

1. The Receiver's Motions and Applications [ECF Nos. 410, 411, 419, 420, & 421] are **GRANTED**.

2. With respect to the Tenth Interim Fee Requests, the Receiver is **AUTHORIZED** and **DIRECTED** to pay herself \$59,238.02 in fees and \$3,554.92 in costs from assets of the receivership estate, which reflects an interim payment of 80% of the allowed fees and 100% of the allowed costs. Allen Matkins' fees and costs are **ALLOWED** and **APPROVED**, on an interim basis, in the amounts of \$102,433.23 and \$3,328.72, respectively, which reflects an interim payment of 80% of the allowed fees and 100% of the allowed costs and 50% of the Murchison litigation fees.

3. With respect to the Eleventh Interim Fee Requests, the Receiver is **AUTHORIZED** and **DIRECTED** to pay herself \$32,004.00 in fees and \$11,933.11

in costs from assets of the receivership estate, which reflects an interim payment of 80% of the allowed fees and 100% of the allowed costs. Allen Matkins' fees and costs are **ALLOWED** and **APPROVED**, on an interim basis, in the amounts of \$87,433.89 and \$842.50, respectively, which amounts reflect an interim payment of 80% of the allowed fees and 100% of the allowed costs and 50% of the Mystic Holdings litigation fees.

4. The hearing on the Motion of Relief Defendant Michael Delgado to Unfreeze Personal Bank Accounts [ECF No. 430] is **CONTINUED** to October 16, 2026, at 9:00 a.m.
